Action Item #1: Meeting Minutes of July 12, 2017

FS Cosgrove made a motion to approve the Minutes of the July 12, 2017 meeting. FS Mazza seconded the motion, which passed unanimously.

Action Item #2: 2015-2018 Transportation Improvement Program Amendment 25

J. Rode first introduced project 0301-0108, *Network Infrastructure Upgrade Phase 3* that was added as a supplement. Amendment 25 also included changes to three other projects. These were 0092-0522 *I-95 West River Bridge BR#00163A*, 0092-0646 *New Haven Area VMS Upgrades* and 0092-0647 *New Haven Area CCTV Upgrades* Following a discussion, FS Banisch made a motion to recommend approval of Amendment 25. FS Mazza seconded the motion, which passed on a majority with Mayor Dickinson and J Bodwell voting against.

Action Item #3: 2018-2021 Transportation Improvement Program Amendment 1

J. Rode presented Amendment 1, which effected 2 projects. Following a discussion, FS Banisch made a motion to recommend approval of Amendment 1. B. Bass seconded the motion, which passed on a majority with Mayor Dickinson voting against

WORKS IN PROGRESS

- Helping distribute CTtransit's new "Route Number and Names Changes Effective October 8,2017" brochure (especially to those that don't have Internet or smartphone access) at mobile food pantries and at brick-and-mortar food pantries/soup kitchens. Although primarily outreaching to people with a disability and people over 65, also addressing veterans with a disability by going to the soup kitchens nearest the West Haven Veterans Hospital.
- Continued presence at Connecticut Food Bank's Mobility Pantry Sites in the south central CT region. Introducing attendees to mobility options and offering current transportation news and literature promoting Know How To Go SCCT, The Kennedy Center's Mobility Services, the Transit Reduced Fare Photo Identification Card Program application, United Way's 2-1-1 info, and more.

The paper material most often taken by attendees: "Transit Reduced Fare Photo Identification Card Program" application, Kennedy Center Travel Training brochure, town street maps and bus schedules.

- Preparing mobility presentations for different audiences at upcoming venues that include the Connecticut Association for Community Transportation (CACT) Statewide Transportation Expo, Greater New Haven Transit District's Board of Director's meeting, Wilbur Cross School, Marc Community Resources Inc., and at a Branford Cares Connects event.
- Helped resolve transportation issues for other people (i.e., senior citizens and people with disabilities) who contacted me for assistance.
