**ITEM 1- Call to Order**

Chairman Sheehy called the meeting to order at 10:10 a.m.

**ITEM 2- Presentation: REX Update**

REX Executive Director Ginny Kozlowski detailed REX accomplishments over the past two years. She also noted REX efforts to secure permanent funding to sustain its operating budget. During the current fiscal year ending June 30, 2012, REX needs \$100,000 to continue operations.

Mayor DeStefano moved to add to the agenda the issue of authorizing SCRCOG to pay to REX the sum of \$50,000 from the SCRCOG reserves to assist REX with its operating budget for the current fiscal year. The payment would be conditioned upon private sector businesses in the area contributing \$50,000 to REX's operating budget in this fiscal year. Mayor Picard seconded the motion to add this issue to the agenda. The vote was 13-1 in favor of the motion to add the issue to the agenda, with Mayor Dickinson voting against. The issue having been added to the agenda by the required two-thirds vote, the motion to authorize the payment on the condition noted was made by Mayor DeStefano and seconded by Mayor Picard. The vote in favor was also 13-1, with Mayor Dickinson against.

**ITEM 3- Adoption of November 16, 2011 SCRCOG meeting minutes:**

Mayor Picard moved that the minutes as presented on pages 3-5 of the agenda packet be approved. Mayor Candelora seconded the motion. It was approved unanimously.

**ITEM 4-Treasurer's Report for month ending December 31, 2011:**

Chairman Sheehy presented the Treasurer's Report which is found on pages 6 and 7 of the agenda packet. Mayor Picard moved for acceptance of the Treasurer's Report. Mayor Candelora seconded the motion which carried unanimously.

**ITEM 5-Nominating Committee Report for Calendar Year 2012 Officers and Committees**

First Selectman McPherson, Chairman of the Nominating Committee, presented the Committee's report which is found on page 8 of the agenda packet.

**ITEM 6- Election of Officers and Appointment of Committees**

First Selectman McPherson moved for acceptance of the nominations contained in the Nominating Committee report. First Selectman Zeoli seconded the motion which was approved unanimously.

**ITEM 7- Passing of Gavel to New Chairman/ Recognition of Outgoing Chairman**

Outgoing Chairman First Selectman Sheehy passed the gavel to Incoming Chairman First Selectman Anthony DaRos. Executive Director Amento presented Outgoing Chairman Sheehy with a plaque in recognition of his outstanding service as SCRCOG Chairman during the past year. The members applauded First Selectman Sheehy.

**ITEM 8-Transportation Committee Report:**

Mayor Dickinson presented the Transportation Committee Report contained on pages 9-32 of the agenda packet. He moved the adoption of a Resolution to Approve 2010-2013 TIP Amendment Twenty Three. First Selectwoman Gorski seconded the motion. It was passed unanimously.

Mayor Dickinson moved the adoption of a Resolution on Ozone Air Quality Conformity. First Selectman Mazza seconded the motion. It passed unanimously.

Mayor Dickinson moved the adoption of a Resolution on PM 2.5 Air Quality Conformity. First Selectman Mazza seconded the motion. It passed unanimously.

Mayor Dickinson moved the adoption of a Resolution to Approve 2012-2015 TIP. Mayor Picard seconded the motion. It passed unanimously.

Mayor Dickinson moved the Adoption of a Resolution to Accept CMAQ Priorities. First Selectman Sheehy seconded the motion. It passed unanimously.

Mayor Dickinson moved the Adoption of a Resolution to Accept Transportation Enhancement Priorities. First Selectman Sheehy seconded. It passed unanimously.

**ITEM 9- Adopt Resolution to Appoint SCRCOG Bank Signatories**

First Selectman Zeoli moved the adoption of the resolution which is contained on page 33 of the agenda packet. First Selectman Sheehy seconded the motion, which was approved unanimously.

**ITEM 10- Adopt Resolution Authorizing the Executive Director to Sign Agreements with CTDOT**

First Selectman Sheehy moved for adoption of the resolution contained on page 34 of the agenda packet. First Selectman Mazza seconded the motion, which was approved unanimously.

**ITEM 11- Adopt a Resolution Authorizing SCRCOG to Accept a Grant Award from FEMA**

First Selectman Sheehy moved adoption of the resolution on page 35 of the agenda accepting a Regional Hazard Mitigation Grant from FEMA. First Selectman Candelora seconded the motion. It passed unanimously.

**ITEM 12- Congressional Report:**

Louis Mangini, *Legislative Aide to Congresswoman Rosa DeLauro* reported that the Transportation bills will go to hearing next month. The House bill is for 6 years but cuts funding. The Senate bill provides more funding but is for 2 years. The federal government provided the state with \$60 million in home heating assistance. This would equate to \$400 per person per heating season. With assistance from Congresswoman DeLauro, the state received an additional \$20 million. The closing of post offices is now in a moratorium. The Congresswoman worked with the VA Hospital in West Haven to obtain an additional 100 spaces for parking served by a valet parking system.

**ITEM 13- State Legislative Report**

Executive Director Amento reported that the General Assembly will convene on February 8<sup>th</sup>. A list of legislators from the region and a schedule of committee deadlines were distributed.

**ITEM 14 SCRCOG Executive Committee Report:**

Executive Director Amento noted SCRCOG's new logo and letterhead. He also pointed to displays of SCRCOG projects hanging on the walls of the conference room. SCRCOG has launched a new website with easier access to information. SCRCOG was recently informed that it has been awarded \$225, 562.50 for a Regional Hazard Mitigation Plan. SCRCOG submitted two Regional Performance Incentive grant applications to OPM, one for a Regional Web-Based GIS and the other for an Inter-municipal Shared Services Feasibility Study. The next SCRCOG meeting on February 22 conflicts with the COST Annual Meeting. Members who will attend the COST meeting indicated that they will send a proxy to the SCRCOG meeting and that the SCRCOG meeting date need not be changed.

**ITEM 15 DESSP/ DEMHS Report:**

Robert Kenny is Acting Region 2 Coordinator temporarily replacing Roy Piper who retired. Mr. Kenny already serves as Region 1 Coordinator. He reported that the Region 2 Coordinator position will soon be posted for applications. There are outstanding payment issues for those seeking reimbursement for the multiple disasters that occurred in recent months. The state is preparing a statewide exercise before August in preparation for the next storm season. The next Region 1 REPT meeting will be on February 6<sup>th</sup> at 9:30 am at the Guilford Fire Headquarters.

**ITEM 16- RPC Action Tables for December and January:**

The Action Tables were reviewed.

**ITEM 17- Regional Cooperation/ Other Business:**

Mayor Dickinson reported that he has been told that new EPA/ DEEP standards for the removal of phosphorus from discharges to fresh water may cost Wallingford \$13 million. Meriden City Manager Kendzior said that the cost may run to \$90 million for the 4 towns of Meriden, Wallingford, Cheshire and Southington.

**ITEM 18- Adjournment:**

First Selectman Mazza moved for adjournment. First Selectman Sheehy seconded the motion and all approved. The meeting adjourned at 11:15 a.m.

***Fiscal Year 2010-Fiscal Year 2013 Transportation Improvement Program Amendment Twenty Four***

*Whereas:* U.S. Department of Transportation “Metropolitan Planning Regulations” (23 *CFR* 450) prescribe that each metropolitan planning organization maintain a financially constrained multi-modal transportation improvement program consistent with a *State Implementation Plan for Air Quality (SIP)* conforming to both U.S. Environmental Protection Administration-established air quality guidelines and *SIP*-established mobile source emissions budgets; and
