They recommended that SCRCOG's current auditor, Kirkaldie, Randall & McNab, LLC, CPAs, be engaged as auditors for a three year term. After discussion, First Selectman DaRos moved for approval of the recommendation. Mayor Capone seconded. All present voted in favor, except for Mayor Dickinson, who was opposed.
