FS Hoey called the meeting to order at 12:02 PM.

#### Action Item #1: Meeting Minutes of January 10, 2024

Mayor Giannattasio made a motion to approve the Minutes of the January 10, 2024, meeting; J Hoefferle seconded the motion, which passed unanimously.

#### Action Item #2: 2021-2024 Transportation Improvement Program Amendment Thirty-Three

G. Filer discussed TIP project 0083-0271, which would replace and renumber highway exit signs along the Wilbur Cross Parkway. Funding from this amendment would expand this project from Milford to Greenwich. The total cost of this project was roughly \$11 million. J. Bodwell made a motion to approve the Transportation Improvement Program Amendment Thirty-Three; A. Quadir seconded the motion, which passed unanimously.

#### **Information Item #3: LOTCIP Update**

J. Rode gave a brief status update of the LOTCIP program. Guilford applied for a road reconstruction project. Wallingford submitted an application for replacement of the Quinnipiac Street Bridge over the Wallace Raceway. New Haven submitted a new application for the Howard Avenue reconstruction project. They also submitted final design plans for the Water Street cycle track project, Quinnipiac Avenue reconstruction project and the Valley Street traffic calming project. They received authorization to advertise these projects. West Haven submitted a new application for the Front Avenue culver project, which is currently under review. J. Rode also mentioned that West Haven received a commitment to fund letter for their Frontage Road and Railroad Avenue improvement project.

FS Hoey asked how SCRCOG is spending the \$68 million of unallocated LOTCIP funds. J. Rode responded by saying that no funds really get spent until design work is fully completed. New Haven did submit several designs totaling \$5-6 million. J. Rode said he would monitor funds as they are spent.

#### **Information Item #4: UPWP Study Solicitations for FY 2025**

- J. Rode announced that SCRCOG is soliciting requests for consultant supported transportation studies for fiscal year 2025. Studies will need to be completed by the end of the fiscal year, (June 30, 2025). An email will be sent out to the municipalities. He asked those present to start thinking of projects in the coming months.
- J. Rode said the deadline for the previous RFQ was on February 5. He along with SCRCOG staff will be interviewing consultants on February 20<sup>th</sup>.

#### **Other Business**

- J. Rode sent out an email for the bus shelter program. CTDOT has issued a survey asking residents how bus shelters should be maintained. The survey is pretty quick, it asks municipalities what their policy is of bus shelter maintenance.
- G. Filer gave an update on SCRCOG's new social media campaign. He invited those present to follow us on Facebook and LinkedIn.
- L McElwee congratulated Madison and Guilford for their new pilot program with River Valley Transit called Extra Mile. This program provides micro-transit services to residents in those communities. More importantly, they transport students and elderly populations to medical appointments, grocery stores, and other areas. This fills a critical transportation gap. Many college students utilize this service, especially students at Wesleyan University. FS Hoey suggested this service be expanded at local high schools and middle schools. Jim said micro-transit is a great way to transport teenagers to jobs.

Mayor Borer asked if there were any transportation grants that assisted residents with food insecurity. Specifically, she was looking to see if there was funding available to help municipalities transport low-income clients to food banks. FS Hoey mentioned that in Guilford there was high demand for transportation to the Yale Medical facility and BIG Y supermarket. He said that micro-transit would add capacity to communities.

J Rode said the Section 5310 grant application is now open. He said that notices have gone out.

FS Hoey made a motion to adjourn at 1:20PM, J Plaziak seconded.

Whereas: The Council, on September 23, 2020, indicated that periodic Program adjustment or amendment was possible; and

Whereas: Council Public Participation Guidelines: Transportation Planning have been observed during the development of the proposed Program amendment (below); and

Whereas: By agreement between the Council and the Connecticut Department of Transportation, public involvement activities carried out by the South Central Regional Council of Governments in response to U.S. Department of Transportation metropolitan planning requirements are intended to satisfy the requirements associated with development of a Statewide Transportation Improvement Program and/or its amendment; and

Whereas: Council of Governments' review of transportation goals, projects and opportunities may result in further adjustment or amendment of the *Program*.
