# 1 Call to Order and Introductions

Chair Lyons called the meeting to order at 2:33pm.

# 2 Adopt Minutes of SCRCOG Meeting November 19, 2025 (motion)

Chair Lyons referred to the minutes of the SCRCOG Board Meeting on November 19, 2025, included in the agenda packet on pages 2-6. Motion made by First Selectman Cardozo and seconded by Mayor Borer. The motion passed unanimously.

## 3 Approve Revision of 2026 Meeting Schedules (motion)

Chair Lyons referred to pages 7-8 of the agenda packet which outlines the revised 2026 meeting schedule for SCRCOG Board, Executive Committee, Transportation Committee, and Regional Planning Commission meetings. Motion made by First Selectman Cardozo to approve the revision altering the January 2026 Board and Executive Committee meeting dates to the third Wednesday. The motion was seconded by Mayor Elicker and passed unanimously.

# 4 Discuss and Approve Preliminary Amendment to the RSG Spending Plan (motion)

Executive Director Francis referred to pages 9-29 of the agenda packet which includes a preliminary amendment to the FY25-26 Regional Services Grant (RSG) spending plan to reflect increased funding to Councils of Governments per the November Special Session Public Act 25-1. A short presentation was provided by Executive Director Francis and Brendon Dukett on the legislation and designated funding for housing planning and technical assistance. The Board was asked to review implementation decisions relating to positions and scopes for housing technical assistance. Discussion followed on the specifics of the potential housing staff position and/or consultant projects. It was mentioned that a decision was also needed on funding allocation for a coordinator position for regional municipal solid waste and recycling or regional stormwater management. A motion was made by First Selectman Brooks to table a decision on this agenda item for a Special Meeting to be scheduled in early January and adjourn the meeting. Chair Lyons seconded. A short discussion followed on what decisions need to be made at the Special Meeting. The motion passed unanimously.
