Guilford – 12,000 lf Linear path from Adams School to Timberland Preserve

In conjunction with Nut Plains Road LOTCIP project - \$656,000

Hamden – Walkable Sidewalk Corridor project – Augur Street, Treadwell Street,

Davis Street, Benham Street \$850,000

Meriden – Coe Avenue School Route Urban Trail \$515,000

New Haven – Bike Share and Traffic Safety Garden- throughout city \$1,114,559

Wallingford – Pedestrian Infrastructure improvements within one half
mile of new train station \$1,000,000

Total requested - \$4,135,559

80% federal = \$3,308,450

Available per outreach - \$3,523,547

Existing Projects that might need additional funding (alphabetical)

Branford – Shoreline Greenway Trail Section B3 \$500,000

Madison – Shoreline Greenway Trail \$300,000

Total requested - \$800,000

80% federal - \$640,000

Per the guidance received, we are asked to provide the Department with **priority ranking for each of the categories**. In addition, the Department has requested that there be up to **THREE new projects**. As the five do not fully utilize the available funding, it seems prudent to prioritize and submit all five.

It remains unclear if the projects requesting additional funding will utilize a portion of the \$3.5 million or will possibly be funded with other Department funds.
