Action Item #1: Meeting Minutes of April 12, 2017

G. Zinn made a motion to approve the Minutes of the April 12, 2017 meeting. B. Bass seconded the motion, which passed unanimously.

Action Item #2: 2015-2018 Transportation Improvement Program Amendment Twenty-Three

J. Rode presented Amendment 23, which consisted of 8 projects. Following a discussion, FS Mazza made a motion to recommend approval of Amendment 23. G. Pidluski seconded the motion, which passed unanimously.

Action Item #3: Recommend approval of final FY2018 and FY2019 UPWP

S. Dudley presented the FY2018 and FY2019 final UPWP for approval. After a brief discussion M. Austin made a motion to recommend approval, J. Portley seconded and motion passed unanimously.

Action Item #4: Discuss and possible actions on TAP Priorities

S. Dudley presented revised cost estimates for 2 projects previously approved as part of the region's Transportation Alternatives Priorities (TAP) list. CTDOT had reviewed the estimated cost for projects in Guilford and Hamden and increased those amounts. S. ***Fiscal Year 2015-Fiscal Year 2018 Transportation Improvement Program Amendment
Twenty-Four***

Whereas: U.S. Department of Transportation “Metropolitan Planning Regulations” (23 *CFR* 450) prescribe that each metropolitan planning organization maintain a financially constrained multi-modal transportation improvement program consistent with a *State Implementation Plan for Air Quality (SIP)* conforming to both U.S. Environmental Protection Administration-established air quality guidelines and *SIP*-established mobile source emissions budgets; and

Whereas: The Council, per 23 *CFR* 450.324 and in cooperation with the Connecticut Department of Transportation (ConnDOT) and public transit operators and relying upon financial constraints offered by ConnDOT, adopted a *Fiscal Year 2015-Fiscal Year 2018 Transportation Improvement Program* on October 22, 2014, after finding the *Program* conforming per U.S. Environmental Protection Administration (U.S. EPA) final conformity rule (40 *CFR* 51 and 93) and relevant Connecticut Department of Transportation air quality conformity determinations: *Air Quality Conformity Reports: Fiscal Year 2015-2018 Transportation Improvement Program* and the Region’s *Long-Range Transportation Plans—2015 to 2040, (April, 2015)*; and

Whereas: The Council, on *October 22, 2014*, indicated that periodic *Program* adjustment or amendment was possible; and

Whereas: Projects referenced in the *Program* amendment (below) are consistent with the region’s long-range transportation plan (*South Central Regional Long Range Transportation Plan—2015 to 2040, (April, 2015)*); and

Whereas: Council *Public Participation Guidelines: Transportation Planning* have been observed during the development of the proposed *Program* amendment (below); and

Whereas: By agreement between the Council and the Connecticut Department of Transportation, public involvement activities carried out by the South Central Regional Council of Governments in response to U.S. Department of Transportation metropolitan planning requirements are intended to satisfy the requirements associated with development of a *Statewide Transportation Improvement Program* and/or its amendment; and

Whereas: Council of Governments’ review of transportation goals, projects and opportunities may result in further adjustment or amendment of the *Program*.

Resolution to accept the State of Good Repair (SGR) Performance Targets set by the Connecticut Department of Transportation (Department) to comply with the Federal Transit Administration's (FTA) Transit Asset Management Final Rule

Whereas: Federal Highway Administration and Federal Transit Administration regulations governing federal transportation assistance, prescribe new requirements for Metropolitan Planning Organizations (MPO's) to coordinate with transit providers, set performance targets, and integrate those performance targets and performance plans into their planning documents. As per 23 CFR 450.324 and 23 CFR 450.326, MPO's are required to reference performance targets and performance based plans into their TIPs and Metropolitan Transportation Plans by October 2018, and:

Whereas: FTA established four SGR Performance Measures in asset categories of Rolling Stock, Equipment, Facilities and Infrastructure. The SGR Performance Targets for these measures were set by the Department in coordination with the transit providers, including Metro North Railroad, Connecticut Transit, and all the rural and urban Transit Districts to comply with January 1, 2017 deadline, and:

Whereas: The MPO is required to establish SGR performance targets for metropolitan areas for each FTA Performance Measure, as per 23 CFR 450.306 (d)(3), 180 days after the transit providers have set their respective performance targets, or by July 1, 2017. If there are multiple asset classes offered in the metropolitan planning area, the MPO should establish targets for each asset class, and:

Whereas: The SGR Performance Measure Targets set by Connecticut Department of Transportation have been reviewed by the Transportation Committee and Transportation Technical Committee on June 14, 2017 and recommended for acceptance by SCRCOG.

Now, Therefore, Be It Resolved By the Council of Governments:

The South Central Regional Council of Governments hereby accepts the State of Good Repair Performance Measures established by the Connecticut Department of Transportation on January 1, 2017.
