ITEM 1- Call to Order

In Chairman Zeoli's absence, Vice Chair Sheehy called to order the January 26, 2011 meeting of the South Central Regional Council of Governments at 10:05 A.M. Self introductions of SCRCOG officials and guests then took place.

ITEM 2 - Presentation- "Connecticut is Broke" by Marcia Marien

Marcia Marien, President of the Connecticut Society of CPAs presented a Power Point presentation on the state's financial statements and compared Connecticut's state financial crisis to that of other states. Ms. Marien distributed her Power Point presentation to the members.

ITEM 3- SCRCOG Minutes of November 17, 2010

Board Secretary, First Selectman DaRos, stated that the SCRCOG Minutes were on pages 4 -6 in the agenda packet.

A motion to adopt the *SCRCOG Minutes of November 17, 2010*, as presented, was offered by First Selectman DaRos and seconded by Mayor Picard. Upon unanimous vote, the motion passed.

ITEM 4 - Treasurer's Report for the Month Ending December 31 2010

SCRCOG Treasurer, Mayor Picard, presented the *Treasurer's Report*, on pages 7 and 8 in the agenda packet. He advised the officials that SCRCOG has assets \$416,000 in Bank of America and New Alliance Bank, and \$254,000 in our STIF account. Half way through the year expenses are in line with our fiscal year budget.

A motion by Mayor Picard, and seconded by First Selectwoman Gorski, was offered to adopt the *Treasurer's Report for the month ending December 31, 2010.* With no further discussion, the motion passed by unanimous vote.

ITEM 5 -Nominating Committee Report for Calendar Year 2011 Officers and Committees

Mayor Richetelli, Chairman of the Nominating Committee, presented the report of the Nominating Committee which is found at page 9 of the agenda packet.

ITEM 6- Election of Officers and appointment of committees

Mayor Richetelli moved to approve the officers and committee assignments recommended in the Nominating Committee's report. First Selectman McPherson seconded the motion, and it passed unanimously.

ITEM 7-Transportation Committee Report

Mayor Dickinson, Chairman of the Transportation Committee reported that the Committee approved TIP Amendment Twelve at its January 19, 2011 meeting. The amendment is detailed on pages 10-22 of the agenda packet. The resolution is on pages 21 and 22 of the agenda packet.

Mayor Dickinson moved approval of TIP Amendment Twelve. Mayor Richetelli seconded the motion, and it passed unanimously.

ITEM 8- Adopt a Resolution to Appoint SCRCOG Bank Signatories

Executive Director Amento pointed out that with the election of new 2011 SCRCOG officers, bank signatories will have to be changed. The resolution is on page 23 of the agenda packet. Mayor Richetelli moved approval of the resolution. First Selectman McPherson seconded the motion, and it passed unanimously.

ITEM 9- Adopt a Resolution authorizing the Executive Director to sign agreements with CTDOT

This is a resolution approved each January by SCRCOG. The resolution is at page 24 of the agenda packet. First Selectman DaRos moved approval of the resolution. Mayor Richetelli seconded the motion, and it passed unanimously.

ITEM 10-Adopt a Resolution authorizing Execution of a grant award with DEMHS for FY2007 Funds

SCRCOG acts as a fiduciary for certain DEMHS funds for our region. The resolution is on page 25 of the agenda packet. Mayor Capone Almon moved approval of the resolution. First Selectman DaRos seconded the motion, and it passed unanimously.

ITEM 11-Adopt a Resolution authorizing Execution of a grant award with DEMHS for FY2008 Funds

SCRCOG acts as a fiduciary for certain DEMHS funds for our region. The resolution is on page 26 of the agenda packet. Mayor Picard moved approval of the resolution. First Selectman McPherson seconded the motion, and it passed unanimously

ITEM 12- Legislative Reports

Executive Director Amento reviewed bills proposed by the General Assembly that affect municipalities and regions. The bills were on pages 27-44 of the January agenda packet. E.D. Amento also distributed a further list of bills which had been proposed after the agenda was sent out.

Lou Mangini, Legislative Aide to Congresswoman Rosa DeLauro, reported that the federal government is operating on continuing resolutions. For Fiscal Year 2011-2012, the President will be presenting his budget proposal in mid-February.

ITEM 13-SCRCOG Executive Director's Report

Executive Director Amento requested that David Fink from HOME Connecticut be permitted to address the members. Mr. Fink noted that a regional housing forum is being planned for May or June, with the assistance of the SCRCOG staff, and that he would be contacting the mayors and first selectmen for input.

E.D. Amento also requested that Neysa Guerino, Executive Director of the Agency on Aging and Bill Hass, President and CEO of FSD, Inc, which provides meals for the elderly in our region be permitted to make a presentation to the members. The presentation highlighted the decrease in funding for the provision of meals to the elderly in our region, and steps that have been proposed to reduce the number of days meals are served at certain senior centers in the region. Ms. Guerino and Mr. Hass intend to meet with mayors and first selectmen in the towns affected by the cutbacks to determine what alternatives may be available.

Executive Director Amento stated that SCRCOG was embarking on several regional initiatives and needed the assistance of the mayors and first selectmen to determine the feasibility of proceeding with each. In order to determine if it would be feasible to have several towns undertake the revaluation process together to save expenses, Amento distributed a survey to each of the members. E.D. Amento distributed a form asking the members to designate a representative from each town to form a regional housing committee to consider the feasibility of attacking the foreclosure crisis at a regional level. E.D. Amento distributed forms for the members to designate a representative to a regional energy committee and to give permission to discuss with the purchasing agent in each town the feasibility of "bundling" the same or similar purchases among several towns.

ITEM 14- Collective Bargaining Project Report

Executive Director Amento noted that the mayors and first selectmen in November expressed an interest in working together on collective bargaining issues. E.D. Amento distributed spreadsheets for each town to input information concerning each of its collective bargaining agreements. The information would then be input on to a master spreadsheet including information from all the towns, which would be distributed to the members. The mayors and first selectmen were welcome to remain after the SCRCOG meeting was adjourned to discuss collective bargaining issues.

ITEM 15- REX Development Executive Director's Report

Ginny Kozlowski reviewed her Executive Director's Report found on page 45 of the agenda packet.

ITEM 16- Appoint First Selectman Michael Freda to Fill Vacancy on REX Development Board of Directors

First Selectwoman Gorski moved to approve the appointment. Mayor Capone Almon seconded the motion and it passed unanimously.

ITEM 17- RWA Special Report

Thomas Chaplik of the Regional Water Authority, Lori Mathieu of the Connecticut Department of Public Health and Betsy Gara of the Connecticut Water Works Association urged SCRCOG to support the inclusion of water infrastructure in the region's Comprehensive Economic Development Strategy (CEDS) so that the RWA would be eligible to receive federal grant funding for upgrading their infrastructure.

ITEM 18- DEMHS Report

Roy Piper reported that the quarterly Region 2 REPT CEO meeting scheduled for February 7th will be cancelled and that the next CEO meeting will be in May.

ITEM 19- Regional Planning Commission Report

The Action Table for January is on pages 46 and 47 of the agenda packet.

ITEM 20- Regional Cooperation/ Other Business

Executive Director Amento distributed the SCRCOG 2011 Legislative Agenda and the 2011 Regional Legislative Agenda approved in December by the Executive Committee.

Given the length of the meeting, it was the consensus of the members to defer the post-meeting discussion on Collective Bargaining issues to the next meeting.

ITEM 21- Adjournment

First Selectman DaRos moved to adjourn the meeting. First Selectman McPherson seconded the motion, which passed unanimously. Chairman Sheehy adjourned the meeting at 12:05 pm.

Resolution Fiscal Year 2010-Fiscal Year 2013 Transportation Improvement Program Amendment Thirteen

- Whereas: U.S. Department of Transportation "Metropolitan Planning Regulations" (23 CFR 450) prescribe that each metropolitan planning organization maintain a financially constrained multi-modal transportation improvement program consistent with a State Implementation Plan for Air Quality (SIP) conforming to both U.S. Environmental Protection Administration-established air quality guidelines and SIP-established mobile source emissions budgets; and
- Whereas: The Council, per 23 CFR 450.324 and in cooperation with the Connecticut Department of Transportation (ConnDOT) and public transit operators and relying upon financial constraints offered by ConnDOT, adopted a Fiscal Year 2010-Fiscal Year 2013 Transportation Improvement Program on October 28, 2009, after finding the Program conforming per U.S. Environmental Protection Administration (U.S. EPA) final conformity rule (40 CFR 51 and 93) and relevant Connecticut Department of Transportation air quality conformity determinations: Air Quality Conformity Reports: Fiscal Year 2010-2013 Transportation Improvement Program and the Region's Long-Range Transportation Plans, May, 2007); and
- *Whereas:* The Council, on October 28, 2009, indicated that periodic *Program* adjustment or amendment was possible; and
- *Whereas:* Projects referenced in the Program amendment (below) are consistent with the region's longrange transportation plan (*South Central Regional Long Range Transportation Plan*—2007 to 2035, (*May*, 2007); and
- *Whereas:* Council *Public Participation Guidelines: Transportation Planning* have been observed during the development of the proposed *Program* amendment (below); and
- *Whereas*: By agreement between the Council and the Connecticut Department of Transportation, public involvement activities carried out by the South Central Regional Council of Governments in response to U.S. Department of Transportation metropolitan planning requirements are intended to satisfy the requirements associated with development of a *Statewide Transportation Improvement Program* and/or its amendment; and
- *Whereas:* Council of Governments' review of transportation goals, projects and opportunities may result in further adjustment or amendment of the *Program*.

AFFIRMATIVE ACTION POLICY STATEMENT

ROOF Proposal to the South Central Regional Council on Governments (SCRCOG) February 2011

What is ROOF?

The Real Options Overcoming Foreclosure (ROOF) Project is a coordinated response to the mortgage foreclosure crisis. Operating in New Haven since 2008, the ROOF Project partner agencies have informed homeowners of free counseling options, saved homeowners from foreclosure, helped tenants secure stable housing after a foreclosure, and turned around vacant and foreclosed properties as fully rehabbed rental and homeownership units.

Need for Expanded Services in the Region:

When ROOF began we believed that the foreclosure crisis would be abating by now. But around the country and here in greater New Haven, homeowners are facing hard times, including job loss and rising energy costs. More homeowners have had trouble keeping up with payments, even on their prime mortgages. And while subprime mortgages were concentrated in urban neighborhoods, the failure of prime mortgages has caused the crisis to expand to surrounding towns. **In SCRCOG municipalities, the number of foreclosure cases increased by 68% from 2,761 in 2008 to 4,631 in 2009.** While the second half of 2010 shows a decline in the number of cases, this appears to be a result of temporary bank moratoriums and not a sign of recovery. We anticipate a return to higher numbers in 2011.

Should we fail to act, families will not benefit from ROOF partner services simply because they will not know where to turn for help. Homeownership will continue to decrease, resulting in a financial loss to families, a loss in the local tax base, an increase in absentee landlords, and a further deterioration of housing stock. Furthermore, the blighted and vacant buildings produced by residential mortgage foreclosures will continue the downward spiral in property values. **ROOF Project partners are poised to partner with municipalities in South Central Connecticut to meet the growing need by regionalizing the ROOF model and expanding services in the region.**

What ROOF [Regional] can accomplish?

The focus of ROOF [Regional] is to provide essential assistance to homeowners and tenants.

Homeowners

• Provide one-on-one counseling services, free of charge, to help borrowers navigate the foreclosure process and access the solutions and resources to either stay in their home or determine the next best option. These resources include the Foreclosure Mediation Program operated through the Connecticut court system, the federal modification program, and state emergency loan programs.

- Provide legal advice to homeowners representing themselves in foreclosure and legal representation for the most challenging cases.
- Ensure that as many homeowners as possible avoid foreclosure scams.

Tenants

- Help tenants whose landlords have been foreclosed upon understand their rights to either stay in their homes or secure alternative housing.
- Legal representation for tenants whose rights have been breached by bank owners who have not provided basic property maintenance or have not allowed tenants to stay in foreclosed properties when they are legally entitled to do so.

How will ROOF [Regional] accomplish these objectives?

SCRCOG will establish a Regional Housing Committee that will partner with ROOF Project partners to design a plan of action to maximize exposure and impact. The following are proposed activities to be used as a starting point for the development of a plan.

Outreach Toolkit

- Weekly letters to all homeowners in foreclosure (can be issued on Mayor/First Selectman's letterhead)
- Flyers and posters advertising resources for homeowners and tenants
- ROOF Project Website
- Foreclosure information sheet customized for each municipality showing foreclosure trends, impact by census tract, and additional recommended data sources to track trends and identify hard hit neighborhoods.

Clinics for Homeowners

- Introductory clinics for homeowners at risk of foreclosure. In addition to clinics in New Haven at Neighborhood Housing Services of New Haven, one clinic per month in Meriden or other municipalities with both a HUD-certified counselor and an attorney.
- Individualized counseling in the months following the introductory clinics, with legal intervention, assistance, and advice as needed.

Capacity Building for Community Leaders:

- Provide workshops for SCRCOG elected officials and/or their designees, community leaders, and social service providers about the foreclosure crisis and available resources for constituents.
- Provide tool kits (see above) of materials for officials to assist constituents and make appropriate referrals to tenants and homeowners

Media & Public Outreach

- Media events in SCRCOG municipalities highlighting partnership between ROOF and municipal officials, as well as available services and local successes in assisting homeowners and tenants.
- ROOF representatives available for public access television and for presentations to civic groups
- Quarterly press releases for municipalities to report on ROOF Project activities

The ROOF Project Executive Committee meets regularly for information sharing, coordination of program activities, and strategizing on unmet needs and future direction. The Executive Committee is made up of representatives from the Greater New Haven Community Loan Fund who are responsible for project oversight and coordination, a representative from the SCRCOG Regional Housing Committee, and a representative(s) from each of the agencies providing direct services to homeowners and tenants in the region.

The Regional Housing Committee is a committee of the SCRCOG responsible for designing a plan of action for the region in partnership with ROOF. SCRCOG will designate a staff liaison to the Regional Housing Committee and each municipality will designate one representative and/or volunteer to serve on the Committee. This representative might be someone in a Mayor's Office, Community Services, Housing Department, or a community volunteer. In addition to serving on the Committee, the representative would be the main point of contact for his or her town or city. He/she would be responsible for guiding local outreach activities, including distribution of flyers/posters, promotion of ROOF Project website, and for assistance in coordinating press events and workshops for community leaders to learn more about foreclosure issues.
