Vehicles parked adjacent to commuter lots are included in the count total and represent demand. Survey totals include both legally and illegally parked vehicles (1) data supplied by New Haven Parking Authority from October 25 - 295 monthlies & 721 transients, total = 1017 When combined with vehicles left overnight the lot reached maximum capacity by 11:00am - (1,145 spaces)
